Application Process

- 4. To apply for the Scholarship, the online application form must be completed and submitted by no later than 15th March 2019 in order to be considered for the Scholarship.
- 5. Cotswold Airport reserves the right to make reasonable changes to the application process and these terms and conditions at any time and will advise applicants, as and when required.

Selection Process/Outcome of Application
